*Foster Child Health Care Card and Ex-Carer Allowance (Child Health Care Card are not eligible.

- If your income is solely from Department Of Veteran Affairs, your annual DVA PAYG statement

If your income is from other sources and you are not required by the ATO to submit a tax return, a Statutory Declaration witnessed in line with Dept Of Justice requirements www.justice.vic.gov.au/statdecs.
